The board (the “**Board**”) of directors (the “**Director(s)**”) of SinoMedia Holding Limited (the “**Company**”) hereby announces that on 11 September 2012 (the “**Date of Grant**”), 1,860,000 share options (the “**Share Options**”) to subscribe for ordinary shares of HK\$0.0003125 each (the “**Share(s)**”) in the Company were granted to certain individuals (the “**Grantees**”), subject to acceptance of the Grantees, under the share option scheme adopted by the Company on 27 May 2008. Each Share Option shall entitle the holder of the Share Option to subscribe for one Share upon exercise of such Share Option at an exercise price of HK\$3.22 per Share, which represents the highest of (i) the closing price of HK\$3.22 per Share as stated in the daily quotation sheets issued by the Stock Exchange on the Date of Grant; (ii) the average closing price of HK\$3.12 per Share as stated in the daily quotation sheets issued by the Stock Exchange for the five business days immediately preceding the Date of Grant; and (iii) the nominal value of the Share.
